1. PURPOSE OF CIRCULARS

- i. Advise of a temporary changes to a current rules;

2. CURRENT CIRCULARS

2.1 CIRCULAR 276 03/04/2008 KNOTTING BUNDLING OF JERSEYS

CIRCULAR 276

TO: QRL Division Managers

DATE: 3 April 2008

RE: **Knotting/Bundling of Jerseys**

The Board of Directors, at its meeting on the 14 March 2008, clarified the League's position on knotting/bundling of jerseys.

The current practice of 'knotting' (pulling together and tying a knot in the jersey) or 'bundling' (pulling together in a bundle or tail and taping) as a method for tightening the fit of a rugby league jersey is no longer permitted.

The elimination of this practice is due to concerns of possible injuries to both the player wearing it and those involved in making a tackle.

Players with loose fitting jerseys should 'tuck' the jersey inside their shorts and fix by tightening the drawstring on the shorts. 'Folding' (folding it over itself like a sheet and fixing with tape) is also permitted.

Please circulate this advice to all Rugby League Bodies and Personnel within the Division so that they are fully aware of and adhere to the Board's decision.

2.2 CIRCULAR 279 17/06/2008 BODY PIERCING & HEAD BEADS

CIRCULAR 279

DATE: 17 June 2008

RE: Body Piercing and Head Beads

The Board of Directors, at its meeting on 19 May 2008, clarified the League's position on the wearing of body piercings and head beads which is becoming more prevalent among players. These matters were brought to the attention of the QRL Board through the Education and Development Advisory Committee in response to concerns regarding player safety.

The Board decided that in the interest of player safety, all visible body jewellery must be removed and non-visible body jewellery must be taped. The Board further decided that players with beads in their hair must wear headgear which covers them.

Please circulate this advice to all Rugby League Bodies and Personnel within the Division so that they are fully aware of and adhere to the Board's decisions.

2.3 CIRCULAR 283 18/11/2008 JERSEY ADVERTISING

CIRCULAR 283

TO: Division Managers
Competitions and Operations Manager

FROM: Managing Director

RE: QRL Rule 138

DATE: 18 November 2008

QRL Circular 262 dated 11 December 2006 is cancelled and replaced by this Circular which covers the League's updated Policy for advertising on playing uniforms.

At its meeting on 14 November 2008 the Board of Directors decided to delete the existing QRL Rule 138 and insert the following in lieu thereof:

138. *All playing uniforms shall normally display the same Sponsors' names and logos. The Managing Director or Authorised Representative may approve exemptions in the case of specific Competitions.*

No player shall be permitted to play in any match under the control of the QRL, a Division or a Local League in any uniform displaying advertising other than that so authorised.

The following advertising is allowed on playing uniforms subject to the approval of the QRL, a Division or a Local League:-

- Jersey	-	Front	-	One Sponsor's Name
		Back	-	Two Sponsors' Names One above Number & One below Number
- Shorts	-	Sleeves	-	Two Sponsors' Logos on each
		Legs	-	One Sponsor's Logo on the front of each
			-	One Sponsor's Logo on the rear of left

The Managing Director or Authorised Representative may approve variations to this Clause where deemed appropriate.

A Sponsor must not conflict with QRL, Division or Local League Sponsors.

All advertising and size of such must be submitted to the Division or the Local League for approval in accordance with the Rules covering the registration of playing uniforms.

Please circulate this advice to all Rugby League Bodies and Personnel within the Division so that they are fully aware of and adhere to the Board's decision. The QRL Rules updated at 14 November 2008 are available on the QRL website.

RE: QRL Insurance program

This Circular is to advise of the increase in insurance premiums for Senior teams for the upcoming 2018 season.

AJ Gallagher has advised that these increases relate to the new provision of a loss of income weekly benefit. This weekly loss of income benefit now provided for every senior player affiliated with the QRL is \$300 per week and kicks in after 28 days from the date of the injury up to 52 weeks maximum payment.

This amount provides rugby league with a median between those participants who do not require loss of income coverage, and those that require a far higher amount. Players who require a higher amount should contact AJ Gallagher to purchase additional cover with top up options available right up to \$1,000 per week.

It is recommended that prior to purchasing additional cover, players should seek individual financial advice to ensure that this product meets their individual needs.
